## **1. Donation of Artwork**

1.1. The Artist agrees to donate the following artwork ("Artwork") to the Charitable Organisation:

3.3. The Charitable Organisation will prominently display the Artist's name and biography alongside the Artwork during the Event. The Charitable Organisation will also issue a certificate of appreciation to the Artist.

3.4. The Charitable Organisation agrees to actively promote the Artist and the donated Artwork on its official social media channels and other promotional materials leading up to and during the Event. This includes using appropriate hashtags and mentions.

3.5. The Charitable Organisation agrees to offer reciprocal support to the Artist's artistic endeavours, which may include promoting the Artist's exhibitions, sharing their artwork on social media, or facilitating networking opportunities within the art community.

#### **4. Responsibilities of the Artist**

4.1. The Artist shall provide the Charitable Organisation with all necessary information about the Artwork, including high-quality images, a detailed description, and the estimated value.

4.2. The Artist shall grant the Charitable Organisation the right to use images and information about the Artwork for promotional purposes related to the Event and the charitable cause.

#### **5. Agreement Termination**

5.1. Either party may terminate this Agreement by providing written notice to the other party at least [Number] days before the termination date.
